### DURATION

### LOCATION

The area covered by the [benetton.com](http://benetton.com) website provided for the following countries: Germany, Switzerland, Austria, Netherlands, Slovakia, Poland, Czech Republic, Sweden, Latvia, Lithuania, Finland, Estonia, Denmark, Belgium, Ireland, Portugal, Spain, Luxembourg, France, Greece, Slovenia, Croatia, Bulgaria, which can be selected via the “country selector” on the website’s homepage and for which the e-commerce service is active.

### PARTICIPANTS

All customers/end users who are resident/domiciled in one of the aforementioned countries, and purchase any of the PRODUCTS IN THE PROMOTION from [benetton.com](http://benetton.com), as stated in the PROCEDURE section below.

### PRODUCTS IN THE PROMOTION

The promotion includes all items in the **BE ACTIVE sportswear collection**, except for **the 3-pack slips**. Items which are on sale and/or part of other promotions are excluded.

The gift cannot be exchanged or changed into money, nor shall participants be entitled to request, with or without an additional sum of money, to receive one or more different gifts, even if lower in value.

The Promoter cannot be held liable for any issues that may transpire when using the gift, or due to inappropriate use by customers.
